and assigns forever, the following described real estate: "All that certain lot of land situate, lying and being near the Corporate limits of the City of Greenville, County and State aforesaid, near the Laurens Road, and being known and designated as Lot No. 82 of Glenn Grove Park, as shown by a subdivision and plat of same made by R.E. Dalton, Engineer in May, 1924, said plat being of record in the R.M.C.
