Lucas, his heirs and

assigns forever, the following described real estate: "All that certain lot of land situate, lying and being near the corporate limits of the City of Greenville, County and State aforesaid, and on the west side of McAdoo Ave. and being known and designated as Lot No. 81 of Glenn Grove Park, as shown by a sub-division and plat of same made by R.E. Dalton, Engineer, in May, 1924, said plat being of record in the R.M.C. Office for Greenville County in Plat Book F., at page 233, and having the following metes and bounds and courses and distances, to-wit: Beginning at an iron pipe on the west side of McAdoo Ave. joint corner of lots 81 and 82, and running thence along the line of Lot No. 82, N. 74-12 W. 150 feet to joint rear corner of lots 98 and 99; thence along the rear line of Lot No. 99, S. 15.48 W. 50 feet to corner of lot No. 80; thence along the line of lot No. 80, S. 74-12 E. 150 feet to iron pipe in line of McAdoo Ave.; thence along the line of said Ave., N. 15.48 E. 50 feet to the beginning corner and being a part of the land conveyed to Home Builders Company by E.
