This Indenture, made and entered into this 19th, day of November, A.D., 1923, by and between Southern Worsted Corporation, a corporation duly organized and existing under and by virtue of the laws of the State of South Carolina, party of the first part, and Southern Power Company, a corporation duly organized and existing under and by virtue of the laws of the State of New Jersey, party of the second part, Witnesseth:

Whereas the party of the first part owns the lot of land hereinafter described, and whereas the party of the second part is desirous of leasing the lot of land for the purpose of installing, operating and maintaining thereon its electrical apparatus, appliances and other property and transmitting electricity or electric power thereto and distributing the same therefrom, so long as it may deem it advisable so to do.

Now, Therefore, in consideration of the premises and the sum of Five Dollars (\$5.00), and other good and valuable considerations to it paid by the party of the second part, the receipt of which is hereby acknowledged, the party of the first part has let, leased and demised, and by these presents does let, lease and demise unto the said Southern Power Company, its successors and assigns, all that certain lot, piece or parcel of land situate, lying and being in or near the City of Paris, Township, Greenville County, State of South Carolina and more particularly described as follows:

Southern Power Co.
Substation Lot Southern Worsted Co.
Paris, S.C.

Beginning at an iron pin South 40 degrees West 48.75 feet from Southeast corner of toilet on Northwest end of West side of Southern Worsted Corporation Mill, at Paris, S.C., and running South 73 degrees West 50 feet to an iron pin; thence South 17 degrees East 50 feet to an iron pin; thence North 73 degrees East 50 feet to an iron pin; thence North 17 degrees West 50 feet to beginning, according to survey made by C.R. Claywell, Sept. 28, 1923, and plat drawn by S.D. Brown, Oct. 8th, 1923, a copy of said plat being attached to and made a part of this description.

To have and to hold the aforesaid lot, piece or parcel of land, and privilege, unto the said Southern Power Company, its successors and assigns, for the use and purpose of installing, operating and maintaining thereon its electrical apparatus, and other property and transmitting electricity or electrical power thereto and distributing the same therefrom, so long as it may desire so to do.

It is expressly understood and agreed that the title to all apparatus and appliances and other property that may be installed upon said lot, piece or parcel of land by the said Southern Power Company, its successors or assigns, shall at all times be and remain in the said Southern Power Company, its successors or assigns.

And the said Southern Power Company, its successors or assigns, shall at ^{any} ~~all~~ all times, during the continuance of this lease, or at the termination hereof, have the right, with the aid and assistance of such persons as it may desire, to enter in and upon said premises and remove, take and carry away the same.
