or property for said Estate, with authority to pay reasonable attorneys fees.

(8) After all debts have been paid and expenses of administering this trust, the remainder of same shall be paid over to C.M. McGee, his Heirs and Assigns.

And the grantor does hereby bind itself, its successors to warrant and forever defend all and singular the said premises unto the said H.K. Townes and C.B. Martin, their successors and assigns against it and its successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
