M. Gaffney

All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, near the Augusta Road School site, on Highland Drive in "A" block

and being known and designated as lot No. 54 of the C. B. MARTIN sub-division, as shown on a plat of record in Plat Book "F," page 102, and having, according to said plat, the following metes and bounds, to-wit:

*Beginning at an iron pin at the Southeastern intersection of Highland Drive and Damascus Avenue and running thence along Damascus Avenue S. 45-50 W. 192.1 feet to an iron pipe thence S. 41-10 W. 71 feet to an iron pipe, joint corner of lot 54 and 55 thence along side of lot 55, N. 48-50 W. 192.1 feet to an iron pipe and Highland Drive; thence along Highland Drive N. 41-10 W. 71 feet to the corner of beginning.*

- (1) No building shall be erected nearer to the abutting sidewalk than thirty feet.
- (2) The property herein conveyed shall never be sold, rented, or otherwise disposed of to a person, or persons, having any percentage of Negro blood.
- (3) The property herein conveyed shall never be used for other than residential purposes, and no residence costing less than Five thousand Dollars

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and his

heirs and assigns, against itself and its successors, and against every person whosoever lawfully claiming or to claim the same or any part thereof.
