Murray and Josephine Murray agree to accept the care, custody, maintenance, education and support of the said child Mary Pauline Parker, during her minority, and further agree to hold and manage and sell all of the property that the said Mary Pauline Parker may come into possession of, and the increase thereof, for her sole use and benefit until she becomes of the age of Twenty-One years; and further agrees to give her a child's part out of any property they may die seized and possessed of.

And Whereas, the said J. H. Murray and Josephine Murray agree to allow me, the said Lila Parker, to visit my said child, Mary Pauline Parker, at any time reasonable, and Now Know All Men By These Presents, That I, the said Lila Parker, of said County and State, for and in consideration of the premises hereinabove stated and for the further consideration, the love and affection I have for and the confidence I repose in the said J. H. Murray and Josephine Murray, have agreed to and do hereby commit the care, custody, maintenance, education and support of my said, Mary Pauline Parker, of the age of about four and one-half years to said J. H. Murray and Josephine Murray.

Together with the rights, privileges and benefits that could be exercised by me, as parent, over and in respect to my said child, Mary Pauline Parker.

To Have and to Hold the said child, Mary Pauline Parker, to the said J. H. Murray and Josephine Murray, during the minority of said child, against me and any and all persons claiming or to claim any interest, right or privilege through me in and to the said Mary Pauline Parker, until she attains the said age of Twenty-One (21) years. I witness my hand and seal this the Twelfth day of January in the year of our Lord One Thousand Nine Hundred and Twenty-Four and in the One hundred and forty-eighth year of the Independence of the United States of America.
