Affidavit.

Personally appeared before me S. A. Curry, Mrs. M. M. Maroney, W. B. F. Curry, H. H. Griffin, Mrs J. P. Brashier, and Mrs W. R. Hammond, who, being each duly sworn, deposes and says:

That they are residents of the County and State aforesaid; that heretofore, Court, on the 19th day of August, 1922, S. A. Curry, Mrs M. M. Maroney, W. B. F. Curry, Mrs H. H. Griffin, Mrs J. P. Brashier and Mrs W. R. Hammond, executed and delivered to H. L. Curry their certain deed in writing whereby they conveyed unto the said H. L. Curry all of their undivided interest in and to a certain lot of land situate in the Town of Simpsonville, County and State aforesaid, being the same lot of land conveyed to the father of the grantors and grantee of said deed by P. A. Green, Sr., that by the terms of said deed it was agreed that the said H. L. Curry, as a part of the consideration of said conveyance, was to take care of and support their mother, Mrs E. M. Curry, the said H. L. Curry maintained, provided for and supported his said mother and the mother of the grantors of said deed, completely and satisfactorily fulfilling and complying with all the terms and conditions of the said deed containing same, and whereas, the said deponents do hereby recognize the title to said property as being vested in the said H. L. Curry absolutely, and that he has fully complied with all the terms and conditions as set forth in said deed of conveyance, and this affidavit is made for the purpose of perpetuating the testimony to the fact that the said H. L. Curry did comply with and carry out and fulfill all the terms and conditions as stated in the deed dated August 19, 1922, which deed was recorded in the R. M. O. Office for Greenville County in Vol. 89, Page 146.
