Witnesseth:

The Grantor being the owner of two (2) lots on Godrich Street, being part of lot No. 65 and lot No. 66 on plot of the property of Pridde & Patton Land Company recorded in plat book "B" at page 249, as appears more fully by deed of Pridde & Patton Land Company dated Sept. 20, 1921 and deed of W. E. Kilpatrick dated Feb. 28, 1923 and recorded in Vol. 72 at page 32, and Vol. 77 at page 47, respectively, R.M.C.
