All that certain piece, to-wit a lot or lands situate,
lying and being in the County of Greenville, State of
South Carolina, in the Suburb of Park Place, and being
at No. 1, of Block #¹ of said subdivision of Park Place
as known on Plat recorded in Plat Book "A" at page 119
in office of R. W. S. in and for Greenville County State
aforesaid.

The above described lot fronts fifty (50) feet on First side
of First Avenue and runs in depth in a westerly di-
rection, being Second street one hundred and fifty (150)
feet to a. trout (10) foot ditch, thence in a northerly direc-
tion along said ditch fifty (50) feet, thence in an easterly
direction one hundred and fifty (150) feet to First Avenue,
thence along First Avenue Fifty (50) feet to the beginning
corner, said corner being the corner of First
