That J. B. B. Harris has hereunto assigned all those certain pieces, parcels or lots of land situate, lying and being in the sub-division of Dextover in Greenville Township, State and County aforesaid, according to plat of J. B. B. Harris property made by S.M. Purman, Jr. Engr., 1924, said lots being more particularly described as follows:

Lot No. 29: Beginning at an iron pin at the corner of Maco Street and Ackley Street and running thence with Ackley Street S. 57-59 W. 157 feet to an iron pin; thence N. 59 W. 38.5 feet to an iron pin, joint corner of lots Nos. 29 and 31; thence along line of lot No. 31, N. 57-45 E. 147.42 feet to an iron pin in Maco Street; thence with Maco Street S. 35-10 E. 54.3 feet to the beginning corner.

Lot No. 30: Beginning at an iron pin 54.3 feet from the corner of Ackley and Maco Streets and running thence S. 57-45 W. 147.42 feet to a stake, joint corner of lots Nos. 29 and 31; thence N. 59 W. 38 feet to a stake, joint corner of lots Nos. 30 and 31; thence N. 57-45 E. 137.37 feet to an iron pin in Maco Street; thence with Maco Street S. 35 feet to the beginning corner.

Lot No. 31: Beginning at an iron pin 101.5 feet from an iron pin at the corner of Ackley and Maco Streets and running thence S. 57-45 W. 137.37 feet to stake, joint corner of lots Nos. 30 and 31; thence N. 59 W. 38 feet to stake, joint corner of lots Nos. 31 and 32; thence N. 57-45 E. 137.37 feet to an iron pin in Maco Street; thence with Maco Street S. 35-10 E. 56 feet to the beginning corner.

Lot No. 32: Beginning at an iron pin 176.7 feet from an iron pin at the corner of Ackley Street and Maco Street and running thence S. 57-45 W. 131.22 feet to a stake, joint corner of lots Nos. 32 and 33; thence N. 59 W. 38 feet to a stake, joint corner of lots Nos. 32 and 33; thence N. 57-45 E. 125.07 feet to an iron pin in Maco Street; thence with Maco Street S. 35-10 E. 56 feet to the beginning corner.

Lot No. 33: Beginning at an iron pin 351.3 feet from an iron pin on the corner of Ackley Street and Maco Street and running thence S. 57-45 W. 125.07 feet to a stake, joint corner of lots Nos. 32 and 33; thence N. 59 W. 38 feet to a stake, joint corner of lots Nos. 33 and 34; thence N. 57-45 E. 118.92 feet to an iron pin on Maco Street; thence with Maco Street S. 35-10 E. 56 feet to the beginning corner.

Lot No. 34: Beginning at an iron pin 238.3 feet from an iron pin at the corner of Ackley and Maco Streets and running thence S. 57-45 W. 118.92 feet to a stake, joint corner of lots Nos. 33 and 34; thence N. 59 W. 38.7 feet to an iron pin; thence N. 57-45 E. 57.3 feet to a stake, joint corner of lot No. 34 and a parcel conveyed by me to Tilnot Smith by deed dated October 18th, 1924; thence N. 57-50 E. 116.95 feet to an iron pin on Maco Street; thence with Maco Street S. 35-10 E. 56 feet to the beginning corner.

All the six lots above described, being all of lot No. 31 and part of lot No. 30 as shown on the plat of Dextover (Clara Fancour property) made by R.E. Dalton, Engr. July 1922) recorded in the S.M.C. Office for Greenville County in Plat Book F, at page 42.
