the receipt whereof is hereby acknowledged to have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
 Purman University, that we have lot or parcels of land situate
 & bounded on the west side of University
 Street in the City of Greenville County and State aforesaid,
 and described as follows:
 Beginning at a point on the northwesterly
 corner of University Street corner of the northwesterly
 extension south side University Street 103 feet, more
 or less, to an iron fence, the northeast corner of
 University Street and Lucia Allen; thence along the
 same to the south side of Lucia Allen; thence along the
 same to the iron fence, corner of Mountain
 property; thence with line of said property in a
 northwesterly direction 109 feet, more or less, to an
 iron fence corner of lot, thence in a northwesterly
 direction with said fence to Mountain and Mill
 Street 100 feet, more or less, to a stone corner of
 the northwesterly direction
 of Lucia Allen and the northeast corner of
 Lucia Baptist Church in a southwesterly direction
 along the line of the property of the trustee of
 Lucia Baptist Church and Purman University
 45 feet more or less, to stone in line of
 University property; thence in a southwesterly direction
 along the line of said University property 113.5 feet
 to a stone thence still with line of said University
 property in a northwesterly direction 50 feet to a
 stone. Thence due west to the line of said University
 property in a southwesterly direction 310 feet, more
 or less, to the point of beginning. Said land
 is all of the real estate owned by Anell Neelie
 on University Street at the time of his death, which
 he devised to his wife Lida A. Neelie, who deeded
 a portion thereof to her mother, Lucia Allen, and
 who, upon her death, devised the remainder to her
