KNOW ALL MEN BY THESE PRESENTS, That

I, W. D. Markman, of the City and  
County of Greenville,in the State aforesaid,  
in consideration of the sum of  
One Thousand Seven Hundred and Fifty Dollars,  
DOLLARS,to W. D. Wallace in hand paid  
at and before the sealing of these presents by Greenville Realty and Investment Co.  
all the premises aforesaid, the laws of the state of South  
Carolina,the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
Greenville Realty and Investment Company, its successors and assigns: All that certain piece,  
parcel or lot of land, situate, lying and being in Ward One of the City of Greenville,  
County and State aforesaid, on the East side of Richardson Street, and being known and  
designated as Lot No. 6 on plat of property of Mrs. M. J. Wharton, made by R. F. Dalton, Engr.  
March 1922, recorded in R.M.C. office for Greenville County in Plat Book "F" at page 87, and  
being more fully described as follows:Beginning at an iron pin on Richardson Street, at corner of an S foot alley, being the N.W.  
corner of said lot, and running thence along the line of Richardson Street S. 20 E. 64 feet  
to an S foot alley; thence along the line of said alley S. 69-10 E. about 55 feet; thence  
continuing along the line of said alley approaching a semi-circle from northeasterly  
direction to a northwesterly direction, to a point where the line of said alley emerges  
into a straight line; thence continuing along the line of said alley, N. 33-25 W. 79-feet  
and 6 inches, more or less, to the beginning corner, and being one of the lots conveyed to  
me by R. Inman, Waster, by deed dated June 25th, 1923, recorded in R.M.C. Office for  
Greenville County in Book "H", page 445.As a part of the consideration hereinabove expressed the grantee herein by accepting this  
deed expressly assumes and promises to pay two certain notes secured by mortgage over the  
above described property aggregating \$21,735.00, together with interest from Dec. 25th, 1923  
until paid. Said mortgage maturing June 25th, 1926 and bearing interest at the rate of 7 1/4  
payable semi-annually, and being more fully described as follows:

1. Note and mortgage in the sum of \$2,000.00, dated June 25th, 1923, executed by W. D. Workman  
to Alester G. Furman, and recorded in Vol. 55, page 145.
2. Note and mortgage in the sum of \$13,735.00, dated June 25th, 1923, executed by W. D. Workman  
to M. J. Wharton and recorded in Vol. 133, page 114.

As a further consideration the grantee assumes the obligation of the grantor to open said  
alleys upon sixty days notice and demand from the owners of the other lots adjoining said  
alleys.TOGETHER with all and singular, the rights, members, inheritments and appurtenances to the said premises belonging, or in anywise incident or  
appertaining.TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Greenville Realty and  
Investment Company, its successors

heirs and assigns, forever.

AND I, W. D. Markman, do hereby bindmyself, my heirs, executors and administrators to warrant and forever defend, all and singular, the said premises unto the said Greenville Realty  
and Investment Company, its successors

heirs and assigns, against

all and singular claim, right, title, interest, demand, cause of action, and

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
