All that piece, parcel or lot of land situate and being in Gantt Township, Greenville County, South Carolina on the Stanton Bridge road near Falcone Church: Beginning at an iron pin on the Stanton Bridge Road at the corner of lands of H. Frank Smith, and running thence N. 31-27 W. 143 ft. 7 in. to an iron pin; thence S. 24-35 W. 100 ft. to an iron pin; thence N. 35-04 E. 937 ft. to an iron stake in the Stanton Bridge Road; thence with said road N. 64-33 E. 600 ft. 7 in. to a stake; thence N. 47-07 E. 263 ft. to a stake; thence N. 42-01 E. 278 1/2 ft. to a stake, the beginning corner, containing 15 acres, more or less, and being tract No. 5 on plat of W.A. Chandler lands, recorded in the R.M.C. for Greenville County in Plat Book C at page 194.

Also all that other piece, or tract of land adjoining the above tract on the west, and containing six and two-tenths acres, more or less: Beginning at a corner of R.D.
