Letta and Joe Prince, Trustees - Stewards of the said Church to make a proper warranty deed in consideration of ten dollars to the one and 15/100 acres of land herein described to the Trustees of School District No. 7-9. Said Trustees now being S.W. Jones, W.F. Gresham and A.D. Tanner and their successors in office.
