the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Mrs. Mary J. Cartledge, her heirs and assigns forever:  
all that certain piece, parcel or lot of land situate, lying  
and being in the State of South Carolina, County and City of Greenville,  
on the North side of Barrancas Street, and being known and designated  
as Lot No. "61-A" of "The West Hills" property, according to a plat thereof  
made by Burton & Nease, Engineers, dated Sept. 1927, and recorded  
in the Office of the C. S. for Greenville County in Plat Book "H" at

page 4, and showing the following notes and bounds:  
Beginning at an iron pipe on Barrancas Street, 97 feet from  
the Northwest corner of Barrancas and McDonald Streets, and running  
thence with Barrancas Street N. 66-06 W. 50.8 feet to an iron pipe  
corner of Lot 61, thence with the line of Lot 61 (in a Northeastern  
direction) 93.5 feet more or less to an iron pin in the eastern  
line of Lot 61, and at the Southern end of a 10-foot Alley; thence  
west 110 feet Southern end of said Alley, land with the Southern line  
of Lot No. 30, S. 76-36 E. 53 feet, more or less, to an iron pipe corner  
of Lot No. 29, said pipe being 97 feet from the western side of  
McDonald Street; thence with the line of Lot No. 29, S. 19-20 W.
