(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

C. L. Hill, all my right, title and interest in and to all that certain piece, parcel or tract of land situate lying and being in the County of Greenville, State of South Carolina, on Fall Creek waters of North Saluda River in Saluda Township, containing 44 1/4 acres, more or less, and bounded on the North by E. S. Stanton lands now belonging to E. S. Hill and lands of Clint Shaper; on the East by E. S. Stanton lands, and the old Anderson-Gordon tracts, on the South by Anderson-Gordon lands now owned by Lewis Lewis heirs and on the West by Anderson-Gordon lands. Being the land conveyed to R. B. Staten by W. H. Stanton.

Beginning to a stone corner of Stanton Grave yard lot, and run N. 36 W. (1 Deg. var) 330 feet to a stone; thence S. 72 W. (1 Deg. var) 363 feet to a stake; thence S. 42 W. 561 feet to a stake; thence S. 12 W. over a rock cliff 173 feet to a chestnut oak, corner of sale to Gordon, also corner of E. S. Stanton 324 acre tract; thence N. 65.30 W. 720 feet to a stake on top of high cliff; thence down the mountain S. 76 W. (2 Deg. var) 523 feet to a stake, between Rock house Cliff; thence N. 10 W. (3.5 Deg. var) 1400 feet to a stone; thence E. (3.5 Deg. var) 1650 feet to a stone, corner of E. S. Stanton tract; thence with his line of same S. 15 W. 522 feet to a stake; thence S. 67 E. 264 feet to a poplar; thence S. 71 E. 153 feet to a stake; thence S. 83 E. 78 feet to a poplar; thence N. 61 E. 224 feet to a stake; thence N. 89.5 E. 91 feet to a stake; thence N. 58 E. 114 feet to a stone; thence S. 3.5 E. passing the corner of Grate yard one-half acre, and into and with line of same 280 feet to the beginning.

From the above described tract of land, one-half of an acre is excepted, being the plot now used for Stanton Grave yard, and located as follows: Beginning to a stone beginning corner of W. H. Stanton tract and run with line of same N. 86 W. (1 Deg. var) 210 feet; thence N. 3.5 W. 105 feet to a stake; thence S. 86 E. (1 Deg. var) 210 feet to a stake in line of said tract; thence with said line S. 3.5 E. 105 feet to the beginning, containing one-half acre.
