All that piece, parcel or tract of land in Greenville County, State of South Carolina, known and designated as tract No. 2 of the Lightfoot Road in Land, as shown by plat made by J. M. Luckett according to survey of May 12, 1905, said land being more particularly described as follows:
Beginning at a point in the bridge over the center of the creek where the Suncombe Road crosses said creek and runs up the right fork of said creek as a line to a Willow at mouth of a branch SSW; thence continuing up the branch of creek as a line 32.50 to a stone SSW; thence N. 84 $\frac{1}{4}$ W. 6.3.35 to a stone SSW; thence S. 52 $\frac{1}{4}$ E. 9.35 to a large Water Oak SSW; thence N. 206.21.00 to a stone SSW; thence S. 4 $\frac{1}{2}$ W. 5.20 to a stone SSW; thence N. 204.6.5.00 to a iron post in road; thence N. 74 $\frac{3}{4}$ W. 2.5.6 to a stone SSW; thence N. 53 $\frac{1}{2}$ W. to a stone; thence N. 61 E. 1.10 to a stone SSW; on the old line; thence along the road as a line 33.14 to a stake; over bridge over branch; thence up the branch as a line 6.50 to a Sweet Gum SSW; head of branch; thence N. 86 $\frac{1}{4}$ W. 5.00 to a Red Oak SSW; thence S. 43 $\frac{1}{4}$ N. 2.9.2 to a stone SSW; thence N. 82 W. 6.00 to a B. C.
