TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That I, A.W. Reynolds, of the County of Greenville,

in consideration of the sum of Ten (\$10.00) DOLLARS,
and other valuable considerations

to me in hand paid at and before the sealing of these presents by Charles League and W.R. Hale, Jr.,
the receipt whereof is hereby acknowledged have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Charles League an undivided one-third interest and unto W.R. Hale, Jr., an undivided one-third interest in and to: All that certain lot of land situate near the incorporate limits of the City of Greenville, on the East side of Jones Avenue, and being a portion of lots designated as Nos. 8 and 9 of the W.C. McCaniel subdivision as shown on plat recorded in the R.M.C. Office in Plat Book "F", at page 168, and having the following metes and bounds, to-wit:- Beginning at an iron pin on the East side of Jones Avenue, said pin being 280 feet North of the Northeast corner of Camille Street and Jones Avenue, and running thence along the North side of Jones Avenue N. 1-00 E. 50 feet to an iron pin; thence S. 89-00 E. 229 feet, more or less, to an iron pin in line of lot No. 30; thence along line of Lot No. 30, S. 5-08 W. 50 feet to an iron pin; thence N. 89-00 W. 225 feet, more or less, to the point of beginning, being a portion of the property conveyed to the grantor by W.W. Griffin, by deed dated April 19th, 1928, and recorded in the R.M.C. Office for Greenville County. It is the intention of the grantor that upon the execution and delivery of the within deed the grantees will be vested with an undivided one-third interest each in the above described property, which they hold as tenants in common with the grantor, who will also be vested with a one-third undivided interest therein. The grantees by the acceptance of this deed assume and agree to pay \$833.33, of the principal amount due by the grantor upon a mortgage executed to W.W. Griffin in the sum of twenty-five hundred (\$2,500.00) Dollars, dated April 19th, 1928, and recorded in the R.M.C. Office in Volume 163, at page 169; covering the lot herein conveyed, together with a fifty foot lot fronting on Jones Avenue adjacent to the property herein conveyed.
