the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said,

R. H. Morton and his heirs and assigns forever, the following described real estate: "All those certain lots of land situated, lying and being in the town of Simpsonville, County of Greenville and State of South Carolina and being known and designated as Lots Nos. 26, 33, 34, 35, 38, 39 and 40, according to a survey and plan of the Estate of S. J. Wilson, made by W. J. Riddle, Surveyor, in August, 1923 and of record in the R.M.C. Office for the County and State aforesaid in Plan Book "P", at page 271, and more particularly described by metes and bounds and courses and distances, to-wit:
