WHEREAS, *H. E. Bell*

on or about the *10th* day of *March* in the year of our Lord nineteen hundred and *twenty-five* exhibited *his* complaint in the Court of Common Pleas, for the County aforesaid, against *Herbert Dyrause, et al*

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the *17th* day of *April* 192*5*, and such proceedings were had therein as resulted in a Decree:

NOW, therefore, Know all Men by these Presents, That I, *E. Inman* Master in and for the County of Greenville, aforesaid, in consideration of the sum of *Twenty-five* Dollars, to me paid by the said *Mollie Dyrause*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

*Mollie Dyrause and her heirs and assigns forever, the following described real estate: All that certain lot of land just outside the limits of the City of Greenville, on the North side of Augusta Street in the County and State aforesaid known as Lot 42-59 on a plat of said property which is recorded in the office of R. M. C. for Greenville County in Plat Book 6, page 137, and having the following notes and bounds:*

*Beginning at a stake on the North side of Augusta Street at the east side intersection of Augusta Street and Wagon Street; running thence N. 43-39 E. 246.1 ft. to a stake thence S. 16-08 E. 87.3 ft. to stake thence S. 43-39 W. 120.0 ft. to stake on Augusta St. thence with said Street N. 46-31 W. 158 feet to the beginning corner being the same lot deeded to Herbert Dyrause by W. E. Bell.*
