the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said,

Sarah M. D. N. Key and her heirs and assigns forever, the following described real estate: "All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, in Ward Five of the city of Greenville Beginning at a point on a 24 foot alley 70 feet and 4 1/2 inches west of the property line on River street, and running thence S. 27-35 E. along the line of S. O. Skelton 106 feet and 4 inches, thence N. 61-12 W. 47 feet, 8 1/2 inches, thence S. 27-30 W. along the line of H. Frank Smith 106 feet, 3 inches to an iron pipe on said alley, thence S. 61-8, 47 feet 6 1/2 inches along said alley to the beginning corner, being parts of Lots 2 and 3 shown on plat recorded in Plat Book "B" page 162."
