the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto  
the said.

H. C. Wood and his heirs and assigns forever, the  
following described real estate:  
All that certain piece parcel of land situated  
lying and being in Greenville County, South Carolina,  
about two miles west of the City of Greenville,  
near the Monaghan Mill in New Hope sub-division,  
said lot being designated as Lot No. 3 on plat of  
New Hope Subdivision, said plat being recorded in  
the R.M.C. office for Greenville County in Plat Book  
A, page 304 and having a frontage of 55 feet on  
Soyt Street and a depth of 150 feet. This being the  
same lot conveyed to E. Inman by J. D. Weller  
and E. Inman to Mrs. Annie Lee Grain and  
by Mrs. Annie Lee Grain to Mrs. E. L. Dowling.
