the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said,

L. B. Houston and his Heirs and assigns forever, the following described real estate; to wit: All that lot of land in Greenville Township, Greenville County, State of South Carolina, in the City limits of Greenville, in Calhoun Street and being located and designated as Lot D in a house on the plat recorded in Plat Book 6, page 13, said lot having a frontage of 35 feet on Calhoun Street and running back in parallel lines 100 feet deep, and being about 100 feet from corner of Calhoun and Duncan streets being the same lot conveyed to Yerica Kay by J. D. White on the 11th day of April 1924, deed recorded in R. M. C. office Gov. Greenville County in Book 99, at page 299.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and of all other persons rightfully claiming from, under, or by these or any of them.
