the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

John D. Ahmora and his heirs and assigns forever the following described real estate: All that certain piece parcel or lot of land situate lying and being in the County of Greenville in South Carolina just outside of the City limits of the City of Greenville, S.C. on the Piedmont or Howell Road and known as lot no. 1 of a subdivision of land known as South Cherokee Park, having the following metes and bounds to-wit: Beginning at stake on said road running thence S. 63 E. 17 1/2 feet to stake on alley thence N. 27 E. 60 feet to stake thence N. 65 W. 17 1/2 feet to stake on corner containing 10,320 square feet, more or less, the plat to said subdivision of land is recorded in the U.M.C.
