the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

M. L. Cathey his heirs and assigns forever the following described real estate: All that certain piece parcel and lot of land situate, lying and being in the township of Greenville known and designated as the front portion of lot 20 of the subdivision known as M. Cullough Heights according to a plat of same recorded in the M. C. Office for Greenville County in plat book "E" page 45 and having the following metes and bounds to wit: Beginning at Saw Creek pin at the intersection of Grove and Donnybrook streets and running thence with Grove street S. 1/4 20.0 feet to a pin corner of lot conveyed by J. Robt. Hughes to M. L. Cathey; thence in a line parallel with line of lot no. 11, 30.5 feet to pin in line of lot no. 19; thence with line of lot no. 19 N. 1/4 20.0 feet to a pin on Donnybrook street thence with Donnybrook street N. 46-25 W. 30.5 feet to the beginning corner, being a portion of the same lot of land conveyed to J.
