the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

J. D. Gilbreath and his heirs and assigns forever, the following described real estate: All that certain piece or parcel or tract of land containing two hundred and fifteen and one-fifth (215 1/5) acres more or less, situated, lying and being about six miles from the town of Campobello, partly in Highland Township, County of Greenville and partly in County of Spartanburg, State of South Carolina, having such shape, metes, course and distance as will more fully appear by reference to a plat of a survey thereof, made for J. D. Atkins, Surveyor, December 23 1918, being bounded on the north by lands of P. Turner, lands of M. Millan and lands of J. M. Lbrance; on the east by lands of J. D. Atkins; on the south by lands of J. O. Wingo, and on the west by Middle Tyegee River, and being the same tract of land conveyed to J. D. Wingo by B. S. Martin by deed dated March 10, 1919, and recorded in the office of the Register of Messrs.
