the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

American Bank & Trust Company, a Corporation, its Successor and assigns forever, the following described real estate, to wit: That certain lot of land, being known as Lot No. 5, Block "D" Carolina Court, as shown on plat of said subdivision, recorded in the R. M. C. office for Greenville County, S. C., and being more particularly described as follows: Beginning at a point on the Eastern side of Montevista Avenue 263.370 feet from the Eastern corner of Montevista Avenue and Lancers Road, and running thence S. 55-21 E. 155.5 feet more or less, to a stake on line of original survey of boundary; thence N. 20-52 E. 65 feet along line of original boundary of survey; thence N. 55-16 W. 185.3 feet to the Eastern line of Montevista Avenue; thence along Montevista Avenue, 23-55 W. 64.6 feet to the point of beginning, being the same lot of land conveyed to W.
