the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

R. J. Watson and his heirs and assigns forever, the following described real estate: All that certain tract of land in the County of Greenville, State of South Carolina, and being known and designated as Tract No. 2 of the estate of Amanda Boyle, as shown by a subdivision and plat of same made by R. E. Dalton, Engineer, on June 1923, and having the following: to-wit: Beginning at a stake in the corner of land formerly of Jerry M. Helger, thence with line of Jerry M. Helger S. 46.57 E. 63.64 feet to an iron pipe corner of land of Mary W. Sullivan; thence with her line S. 3.50 W. 583 feet to an iron pipe corner of land of Robert Mickelpe, thence with his line N. 45.25 W. 370.5 feet to an iron pin corner of Lot No. 1; thence with line of said Lot No. 1, N. 55.20 W. 553 feet to an iron pin in the N.
