the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said

J. W. Fowler and his heirs and assigns forever, all the right, title and interest of the said *John R. Kelleett, deceased* which is an undivided one-third interest in and to all those certain tracts of land in the state and county aforesaid and being the same tracts of land conveyed to *C. R. Kelleett, J. R. Kelleett and C. P. Armstrong* by deed dated Jan. 1, 1920 and being the same conveyed to *M. D. Nash* by *Ezra T. Bellenger et al.* by deed dated Jan. 1, 1920 and recorded in the office of *R. M. C. for Greenville County* in *Deed Book 55* at page 1621 and being more specifically described as tract No. 2 said containing 33 acres more or less, tract No. 3 containing 39.96 acres more or less and tract No. 4 containing 64 acres, more or less in a survey and division of the estate of *M. D. Nash* dead, said lands being specifically described in the deeds as aforesaid and upon plates made in the said *M. D. Nash* estate division.
