and *me* heirs and assigns forever, all *that piece parcel or tract of land situate, lying and being in the State of South Carolina, in District of South Carolina, containing seventy five (75) acres, more or less, and being the same tract of land as conveyed to J. A. Garrett, by Elbert S. Oberlin, by deed dated Nov. 16th, 1923, as recorded in R. M. C. Office for Greenville County in Book 82 at page 294, reference to which deed is hereby made for a full and complete description.*

TOGETHER with all and singular the rights, members, hereditaments and appurtenances whatsoever to the said premises belonging, or in anywise appertaining, and the reversions and the remainders, rents, issues and profits thereof; and also all the estate, right, title, interest, dower, possession, property, benefit, claim and demand whatsoever, both at law and in equity, of the said *J. A. Garrett, deceased*
