and *his* heirs and assigns forever, all *this*, *in*, or *barrel* of land
lying and being situated *two miles west* *on the*
South *to* *East* *boundary*, *in the County and State*
aforesaid, *on the north side* *of the Georgia Road*,
and containing 89.18 acres *more or less*, *bounded by*
lands of Mr. A. L. Hammond, H. J. Boyd
and others, *commencing* *at a stone* *on the Georgia*
Road, H. C. Hammons corner, *and running thence*
N. 11° W. 42.60 to stone; thence N. 87° W. 153.76 to P. O.;
thence S. 11° W. 16.70 to stone; thence S. 37° E. 5.65 to
stone; thence S. 8° W. 20.12 to point on Georgia Road;
