as Judge of the Court of Probate for Greenville County, in the said State, SEND GREETING:

WHEREAS, *A. P. Miller* as executor of the estate of *Janie Scott, deceased*

on or about the *14th* day of *August* in the year one thousand nine hundred and *twenty nine* did exhibit *this* Complaint in the Court of Probate, in the County of Greenville and State aforesaid, for the sale of the Real Estate of *Janie Scott, deceased* in aid of personal assets to pay debts of the deceased.

And the cause being at issue before the Honorable the Court aforesaid, came on to be heard on the *20th* day of *September* one thousand nine hundred and *29*, when the said Court, after a full hearing thereof and mature deliberation in the premises, Did Order, Adjudge and Decree that the real estate hereinafter mentioned and described, should be sold at public auction by the Judge of the Court of Probate for Greenville County, on the terms and for the purposes mentioned in the said Decretal Order, as by reference thereto, on file in the said Court, will appear: And the said Judge of the Court of Probate, after having duly advertised the said lands or real estate for sale by public outcry, on the *7th* day of *October* in the year of our Lord one thousand nine hundred and *twenty-nine*

did then, openly and publicly and according to the custom of auctions, sell and dispose of the said real estate described below unto *Louise S. Sawyer* for *Eight Hundred and twenty + 00/100* Dollars, being at that price the highest bidder for same.

NOW, KNOW ALL MEN, That I, the said *Fannie S. Scott*, as Judge of the Court of Probate as aforesaid, in consideration of the premises, and also in consideration of the sum of *Eight Hundred and twenty + 00/100* Dollars, paid me by the said *Louise S. Sawyer* the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *Louise S. Sawyer* and *her* heirs and assigns forever, all *that certain lot of land in the City of Greenville, Greenville County, South Carolina, beginning on the West side of Chisler Avenue, 60 feet north of No. 7, and running thence with Chisler Avenue north 50 feet to corner of lot No. 2, thence S 79° 15' 00" West to Dixon Avenue, thence S 11° 00' 00" West with Dixon Avenue to corner of lot No. 7, thence N 79° 00' 00" West to the beginning corner, and being lot No. 1 according to a plat of West Side Land Improvement Company, recorded in Plat Book A at page 153, P.M. 6 Office for said Greenville County, S.C. and the same conveyed to me by Susan S. Miller by deed dated June 20th, 1918, and recorded in Deed Book 25 of page 203, in said P.M. 6 Office*

TOGETHER with all and singular the rights, members, hereditaments and appurtenances whatsoever to the said premises belonging, or in anywise appertaining, and the reversions and the remainders, rents, issues and profits thereof; and also all the estate, right, title, interest, dower, possession, property, benefit, claim and demand whatsoever, both at law and in equity, of the said *Janie Scott, deceased* and of all the parties to the said suit, and of all other persons rightfully claiming or to claim the same or any part thereof, by, from or under them, or either of them. TO HAVE AND TO HOLD, the said premises with its hereditaments, privileges and appurtenances unto the said *Louise S. Sawyer* Heirs and Assigns forever. IN WITNESS WHEREOF, I, the said *Fannie S.
