

State of South Carolina / Release of Judgment  
County of Greenville

Whereas, The Peoples Bank of  
Fountain, S.C. obtained a judgment against  
H. D. Workman and Stella D. Stone, in the Court  
of Common Pleas, which judgment was entered  
on the day of - 1926, and is on  
file in the office of the Clerk of Court Com-  
mon Pleas for Greenville County, in judgment  
Roll C-290, and being for eight thousand  
seven hundred ninety nine and <sup>25</sup>/<sub>100</sub> (\$8,799.35)  
dollars;

Now, for value received the South Carolina  
Savings Bank, as receiver for the Peoples  
Bank of Fountain, S.C. does hereby release  
and relinquish from the lien of the aforesaid  
judgment the property which is hereinafter  
described. It is understood and agreed,  
however, and specifically intended by this  
release, that the said judgment shall not  
in any manner be affected, nor shall the  
lien of the said judgment in any manner  
removed from any property now owned or  
hereafter owned by H. D. Workman and  
Stella D. Stone, except that which is here-  
inafter described, but that property shall  
be free from signing of this release for any  
of the lien of the judgment as aforesaid  
to and which is released by this instrument  
is as follows:
