in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Mirass S. Syltson, his heirs and assigns

all that piece, parcel or lot of land in Greenville, Township, Greenville County, State of South Carolina, being known and designated as lot No. 3, of block six of Section "A" Garslands Estates, according to plat thereof recorded in the R. M. C. Office for Greenville County, in plat book 1, page 21 to 24. Reference to said plat being made for a more complete description of said lot see also Vol. 11, page 261. In accepting this deed the grantee herein agrees that the following restrictions are covenants running with the land and that in the event of violation of any of them, the property herein conveyed shall revert to the immediate grantor.

- (1) The grantee herein binds himself, his and assigns, never to publicly advertise for sale any lot or lots, if they be subdivided at a price less than that which the grantor is advertising similar lots in said Garslands Estates;
- (2) No lot in this subdivision shall be sold, leased or rented in any manner, directly or indirectly, by any title either legal or equitable, to any person, white or black, Caucasian race, nor to any corporation of which any stockholder shall be other than of the Caucasian race;
- (3) No insurance shall be permitted to be maintained on any lot in this subdivision.

The above described land is Lot 41, 3, the same conveyed to me by Gtownsh Realty Corporation, on the 2nd day of Oct 1926, in Book 111, Page 116, recorded in office of Register of Mesne Conveyance for Greenville County, in Book 111, Page 116, TO HAVE AND TO HOLD, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said Mirass S. Syltson, his heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Mirass S. Syltson, his, and every other heirs and assigns, against me and my person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
