all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

In the city of Greenville situated on the southeast corner of Hampton Avenue and Mulberry Street, and having the following metes and bounds, to wit:

Beginning at the corner of Hampton Avenue and Mulberry Street and running thence with Mulberry Street south 58° 7' west 119 feet to an iron pin; thence south 31° 35' east 104 feet to a stake; thence north 57° 23' east 120.6 feet to a stake in the margin of Hampton Avenue; thence with the margin of Hampton Avenue north 32° west 102.7 feet to the beginning corner.

As a part of the consideration for the foregoing land the party of the second part agreed and assumed and undertakes to pay a certain indebtedness now upon said property due the Atlantic Life Insurance Company, which is secured by a mortgage dated the 15th day of March, 1926 for the sum of fifteen thousand dollars, which said mortgage is recorded in Book of Mortgages #64 at page 98 of the Register's Office of Greenville County, S.C.
