all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina, in and to all that Portion of the lot as lies south of a line drawn exactly through the center of all that Parcel, Part of a lot of land in Greenville Township, Greenville County, State of South Carolina, with the building thereon, situate on the east side of North Main Street between Coffee & North Streets fronting said main street 51 feet, more or less, and extending back 135 feet and 6 inches, the building being 125 feet and 6 inches and the strip of land at the rear 16 feet wide to be used in common with the owners of that Portion abutting main street and by those turning that abutting Brown Street. Being the same property described in deed of E. Inniss, master recorded in the R. M. C. office for Greenville County in vol. 46, at page 45.

The consideration for this conveyance is as follows: The grantees herein have agreed to assume and pay certain note and mortgage executed by the grantor herein and John A. Babb and Edna B. Robinson to Florence Coffey on April 1, 1927, in the sum of \$2725.00 for which amount the grantee herein was primarily liable. It being her duty also the grantees are to assume and pay balance due on judgment of S. P. McElvee against grantor and J. L. Rhodes in the sum of \$5 97.72 and costs also note of J. L. Rhodes and the grantor herein to the Bank of Commerce dated Sept. 27, 1926, for \$400.00 and interest, which the grantor herein are also to assume and pay. The grantees, also, are to pay the balance on note executed by J. L. and Ella V. Rhodes on May 1st, 1925, to Otis Garrison for the sum of \$400.00, said note, now being held by the Mutual Auto Company.
