(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Nell H. Parrish, all that certain piece, parcel or lot of land situate, lying and being within the City of Greenville on the East side of Jones Avenue, and being known and designated as Lot No. 6 of the H. G. McDaniel subdivision as shown on plat recorded in the A. M. Co. Office for Greenville County in Plat Book X, at page 186 and having according to said plat the following lines and bounds to wit: Beginning at an iron pin on the East side of Jones Avenue, point corner of Lots Nos. 5 and 6 and running thence with the point line of said lots S. 89 degrees 51' feet to an iron pin, thence S. 1,01 E. 70.05 feet to an iron pin corner of Lot No. 7, thence with the line of that lot N. 89 W. 1,01 E. 70.05 feet to an iron pin on the east side of Jones Avenue, thence with said line N. 1-00 E. 70 feet to the point of beginning, and being a portion of the property devised to me by the will of my father, J. A. McDaniel.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *Nell H. Parrish, her* heirs and assigns, forever.

Subject however, to the following conditions & Building restrictions: no building shall be erected on said lot nearer to the abutting side wall than thirty (30) feet nor shall the property be sold, conveyed, leased or otherwise disposed of to any person having any percentage of Negro blood.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Nell H. Parrish, her* heirs and assigns, against

heirs, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
