W. D. Workman his heirs and assigns: All that certain
tract of land known as the Alex Finley Stock farm
containing 150 acres, more or less and composed of
two tracts as follows:
No. ① All that tract of land containing 143 acres, more
or less, conveyed to said Alex Finley by Sammie Mauldin by
deed dated Nov. 2nd 1896 and recorded in Book XX at page
506 and described on a plat made by J. N. Southern
and M. S. French and recorded in plat book "A" at
page 505, reference thereto being made for a full
description thereof.
No. ② All that tract of land containing 8 1/4 acres, more
or less, conveyed to said Alex Finley by M. W. Fowler
by deed dated Nov. 2nd 1896 and recorded in deed
book 6 C. at page 410 and described on a plat
recorded in office of R. M. C. for Greenville County in
plat book A at page 504. All of above described
land being the same conveyed to me by E. C. Man, Master
Feb. 16th 1925 by deed recorded in Book 110 at page 29.
It is understood and agreed and made a part of this
consideration of this conveyance that the grantee herein
is to assume and pay and he hereby assumes and
agrees to pay a certain mortgage covering this property
given by Sammie L. Phillips to E. P. Taylor for \$12,500.00
recorded in vol. 69 at page 189; the assumption being
with interest at the rate of eight per cent per annum
instead of seven as provided for in mortgage, said
rate having been increased by agreement since the
execution and delivery of the mortgage. The assumption
to be of \$12,500.00 with interest from this date, the back
interest to be paid by the grantor.
Taxes to be pro-rated. Rent for 1925 to be reserved by the
Grantor.
