Richardson* in and to *me* and my heirs all that certain piece of land situate, lying, situated and being in the County of Greenville, State of South Carolina, and being more particularly described as follows, to wit: Beginning at the corner pin on the South side of Princes Avenue, 26.5 feet from the corner of Church Street and 20 feet from the N. E. corner of the subdivision of D.P. Wick, 100 feet, thence along the South side of Princes Avenue, 120 feet, to the corner pin of lot No. 4, thence with line of lot No. 4, S. 44-53 E. 153 feet to an iron pin corner of lot No. 12; W. 60 feet to iron pin corner of lot No. 2; thence with line of lot No. 2, N. 44-33 W. 180 feet to the corner pin on the South side of Princes Avenue, the beginning point, and being the same tract of land conveyed to me by R.
