the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Fall L. Thomason and Isabel C. Hitchin, all that certain piece of land situate in Greenville, State of South Carolina, being two and one half miles from the City of Greenville, and known as lot part of the tract of land described in G. B. Martin, according to plat of said property made by G. B. Martin, G. S. Surveyor, dated 1823, said plat record in the office of the County Court in plat book F at page 162, and lot being more particularly described as follows:

Bounding at the Southwest corner of Main Street and Somerage Avenue, and running thence northwardly and Highland Drive #41-16-20, then left to a point seven and one half feet from the corner of lot #52, so running eastwardly, then 80 ft. 48-50-20, 192.1 feet to an iron pin, thence N. 41-15-75 feet to a corner pin, thence N. 48-50 E. 192.1 feet to the point of beginning.

This is the same lot of land conveyed to me by the American Bank and Trust Company, as Trustee and it is understood and agreed by and between the grantor and grantees herein named that said grantors agree to assume and pay a note secured by a mortgage on the within described premises for the sum of \$5000.00 executed to the Peoples Building and Loan Association on May 1st, 1924.
