Carolina, being about five miles Southeast from
Greenville, County, State of South Carolina, on the White Horse Road

title of the office of Probate Court in and for
County of Greenville, State of South Carolina, and said tract is described
as follows: Beginning at the center of road 3063 ft.
East of the center of White Horse Road at
