all that certain piece, parcel or lot of land  
situate, lying and being in the State of  
South Carolina and in the County of Greenville,  
more particularly of the City of Greenville and  
more particularly designated as lot no. 40  
according to a plat of the property of Overbrook  
and in said plat, Sept. 17, 1913, by St. Allen  
and in said plat which plat is of record in  
the office of the Register of Deeds in the County of Greenville  
in said plat book "C" at  
pages 35 and 36, said lot of land is  
described by metes and bounds as follows

beginning at an iron pin on the East side  
of a certain unnamed street as shown on  
said plat, which point of beginning is
