(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Jadie Poole Farmer, all my undivided one ninth interest in and to the following described real estate, all that certain tract of land situate in Chick Springs Township on the Chick Springs Road in the County and State aforesaid, containing one hundred (100) acres more or less, and adjoining lands of W. B. Ladd, P. G. Roberts, Southern Watered Company and the Southern Railway Co. right of way.

Also all that other tract of land situate in Chick Springs Township, Greenville County, S.C. containing fifty (50) acres, more or less, and adjoining lands of P. G. Roberts, J. D. Roberts and Southern Watered Company. This is the property of which my father A. Farmer died seized and possessed and I acquired a one-ninth interest therein under his Will which was admitted to probate in the office of the Judge of Probate for Greenville County, S.C.

And I hereby assign, transfer and set over unto the said Jadie Poole Farmer all my right title and interest in and to a certain note executed by W. J. Hendlock and Nancy M. Hendlock to A.
