at and before the sealing of these presents by Eva McDonald Timmons

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Eva McDonald Timmons, his heirs and assigns, forever, all those pieces, parcels or lots of land in Greenville Township, Greenville County, State of South Carolina, and in the City of Greenville, described as follows:

First: Beginning at an iron pipe on the east side of Bennett Street, 74 feet from the northeast corner of Bennett Street and Swiss Avenue; thence along the east side of Bennett Street N. 19-30 E. 75 feet to an iron pipe; thence along the south side of a 50 foot street S. 70-30 E. 150 feet to an iron pipe; thence along property of H.K. Townes, Trustee S. 19-30 W. 75 feet to an iron pipe; thence along line of lot of grantor N. 70-30 W. 150 feet to the pipe on east side of Bennett Street at the beginning.

Second: Beginning at an iron pipe on the west side of Bennett Street 71 feet from the northwest corner of Swiss Avenue and Bennett Street; thence along the west side of Bennett Street N. 19-30 E. 70 feet to an iron pipe; thence at right angle to Bennett Street N. 70-30 W. 165 feet to an iron pipe on rear line; thence along rear along property of H.K. Townes, Trustee, S. 19-30 W. 70 feet to an iron pipe; thence S. 70-30 E. 165 feet to the iron pipe at beginning.

As a part of the consideration for each of the above lots, it is understood and agreed by the grantee, Eva McDonald Timmons, her heirs and assigns, that by accepting this deed, that no dwelling house shall be erected thereon costing less than Five Thousand (\$5,000.00) Dollars, and that no person of African descent shall hold the possession of said lots or occupy same.

Further, as a part of the consideration for this conveyance, the grantee herein does hereby assume and will pay a note and mortgage, according to their terms, given by John W. Lipscomb to Carolina Loan and Trust Co., on Jan. 15th, 1925, bearing interest at 5% and in amount \$1,500.00.

These lots are two of the same lots conveyed to grantor by H.K. Townes, Trustee, December 26th, 1924 and recorded in R.M.C. Vol. at page
