KNOW ALL MEN BY THESE PRESENTS, That I, J. P. McBee, citizen of the City and County of Greenville, do hereby convey unto Marcellle Banks McKinney, in the State aforesaid, in consideration of the sum of One hundred and twenty five dollars, DOLLARS, and other valuable considerations to me in hand paid at and before the sealing of these presents by Marcellle Banks McKinney.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Marcellle Banks McKinney, her heirs and assigns, a certain lot of land situated, lying and being in Ward two of the City of Greenville, recently laid street aforesaid and described, one and one-half acres and boundaries to-wit: Beginning at the corner where the eastern side of the intersection of Marion Street laid iron pipe being the northerly boundary to lot no. 8-3 and the southwesterly corner of lot no. 8-4 and running thence to the west side of the intersection of Marion Street laid iron pipe, thence 90° 58' 37" E. 58' 6" due N. to the corner thence 90° 56' 8" E. 250.4 feet to the iron pipe on the west side of the Spartanburg road thence 84° 49' 21.78.5 feet to an iron pipe on the corner of the intersection, - deeds, piping, lots no. 8-4 and 8-5, all in great part of the Overbrook Land Company's subdivision recorded in plat book "E" at page 201, said land having been made subject to the aforesaid restrictions, that the property herein conveyed shall not be sold to any person or persons as follows:

The above described land is the same conveyed to me by J. P. McBee, on the 24th day of April 1924, deed recorded in office of Register of Deeds Conveyance for Greenville County, in Book 62, Page 544, together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Marcellle Banks McKinney for heirs, and assigns, forever.

AND I, J. P. McBee, do hereby bind

myself and my heirs, executors and administrators, to warrant and forever defend all and singular, the said premises unto the said Marcellle Banks McKinney

and his, executors and administrators, to warrant and forever defend all and singular, the said premises unto the said Marcellle Banks McKinney and his, executors and administrators, against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
