(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said C. F. Putman all that certain piece, parcel or tract of land situate, lying and being in the County and State aforesaid, in Bent Township, about three and one half miles from the County Court House between the Parkers Mill Road and the Augusta Road, and having the following metes and bounds, to wit: Beginning at a stone 3207m and running thence S. 14° E. 15' 50" Che. to a stone 3207m; thence N. 24° 44' W. 15' 54" Che. to a stone 3207m; thence N. 65° 46' E. 13' 53" Che. to the beginning corner and containing 17.95 acres, more or less, adjoining lands of Alex Cagle, Mrs. Sullivan and others, less, however, and excepting from the above described tract a certain tract heretofore conveyed by the Grantor to W. A. Chandler, on the 5th day of September, 1924, deed recorded in vol. 47, page 130, R. M. C.
