the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said J. N. and Martha Ellen Watson, all that piece of land, in the City of Greenville, Greenville County, State of South Carolina, being lots 13 and 14 in Block 6 of the original Court, Subdivision A, plat of said subdivision being recorded in Office for R. M. C. for Land, Book 10, page 13, and having the following boundaries reckoning the said plat:
