Roberts, an undivided one-half interest in and to that certain parcel of land, in the city of Greenville, Greenville Township, County of Greenville on the east side of Pittman street, and being lot number one (1) as shown by Plat made by W. H. Nease, dated Greenville 1st, 1921, and is a part of the sub-division made by the said W. H. St. Griffin and having the following corner and boundary description, to-wit: Beginning at the northeast intersection of said Pittman street and Whitehill street and running thence north forty-one degrees, forty-five minutes, sixty-six feet; thence north eighty-two degrees, thirty-seven minutes, East seventy-seven and seven-tenths feet; thence South Twenty-one degrees, twenty-eighty-seven feet to Whitehill street; thence along Whitehill street south seventy-seven degrees, thirty-five minutes, 116' 30" feet, and six-tenths feet to the beginning corner, being the same lot in all respects as that Conveyed to W.
