(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

H. P. Mcgee, his heirs and assigns,
all that certain piece, parcels or lot of
land in Greenville Township, Greenville
County, State South Carolina, in West
Greenville on the south side of a twelve
foot Alley running eastward from Bob
Street, and having the following Courses
and dimensions according to a survey made
by G. W. Millard Englewood April 1924
beginning at an iron pipe in the
center of said 12 foot Alley, 105 feet
east of Bob Street, and running thence
with three of other property of Claude
Lynton but now owned by Era Reed,
N. 6° 45' E. 35' 8.5 feet to an iron pin thence
S. 6° 45' E. 35' 8.5 feet to a fence Post, thence
N. 22° 45' E. 35' 0 feet to a stake in center of
said Alley, thence with said Alley N. 6° 45' 30
feet to the beginning Course less, how-
ever, land excepting from the above de-
scribed lot the following lot which has
heretofore been conveyed by H. C. Wright
to A. W. Wright to W. T. Patrick and
H. M. Hartling, more particularly described
as follows: all that piece, parcel or lot
of land in Greenville Township, State and
County aforesaid, in West Greenville, and
having the following Courses and distances
to wit: Beginning at a point 29 $\frac{1}{4}$ feet
from an iron pin which lies about 105
feet in an easterly direction from Bob
Street adjoining property of Mrs. Alice
F. Smith, and running E. 67° 30' E.
29 $\frac{1}{4}$ feet, thence S. 33° 45' W. 67° 30' feet
thence N. 67° 30' W. 29 $\frac{1}{4}$ feet, thence N. 67° 30'
feet back to the beginning point

Wright by deed dated September
