ing on Nichols Street, and having the following dimensions
and bounds, to-wit : Beginning at the corner of

E. 50 feet; thence N. 13 E. 140 feet to a stake on
Gowrie line; thence with said line N. 76 1/2 W.
50 feet to a stake; thence with Sherman's line
N. 12 1/2 E. 141 feet to the beginning corner.
